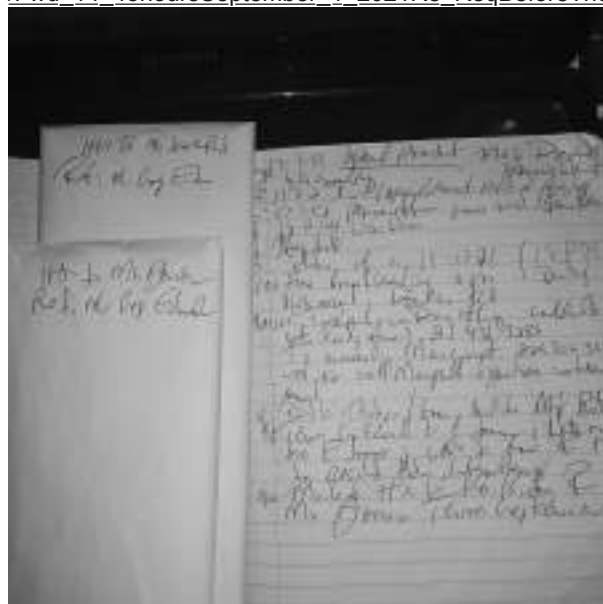

Dear Judge Ken Hodges:

I do recall your firm service as District Attorney to Dougherty County-Albany, GA. Since July 27, 2021 I have attempted to submit a 14-page amended application for criminal warrant as well as the 6 page defendant-specific county forms. However the African-American magistrate judge Victoria Johnson, mostly likely a drug cartel affiliate, refused to accept the filing that pertained, inter alia, to nurses at Albany's mental health clinic performing non-licensed medical services, including force sedation. Another one of the six defendants is a cold, stout, violent-natured deputy who, it is my belief, also serves the cartel.

Since July 2021 I have emailed the lengthy, compendious amendment to Dougherty County's present District Attorney Mr. Greg Edwards that has not responded to any of the emails---the last of which had a deadline of August 31 2021 in which I requested a SPECIAL PRESENTMENT to the grand jury. Therefore I sought email or postal address contact information for members of Dougherty County's grand jury or that Edwards forward my amendment to that body.

Article VI Section VIII Paragraph I speaks of how Georgia's county DA's are elected. This is an error for Georgia's District Attorney should be elected by vote of all seated judges of each court---Magistrate, Probate, State, Superior, Court Of Appeals and Supreme Court.

Judge Hodges please act exigently as an informed peer to these matters to have the governor send by interim appointment your two closest colleagues in order to serve as assistant Magistrate judge and District Attorney of Dougherty County. If time permits please review the principal brief of my case Federal 11th Dist. MDGA 1:20-cv-0230 that names the Judicial Qualifications Commission as a defendant. The JQC did nothing concerning my meritorious complaints against a Muscogee County Probate Court Judge and an admin. law judge.

The time to act in the manner of President of the United States of America Franklin D. Roosevelt is now! I will send a PDF link to the complete text of this letter to the Honorable Governor Mr. Brian Kemp to enact within the State of Georgia's borders Martial Law order and order that the medical marijuana oils be repel from Georgia's law books because the aforementioned Constitutional provisions, OCGA 15-10-20 and the medical marijuana oil statute are obsolete and will fail the citizens of Georgia whose good Christian votes are being overridden by those whose inebriate, mistake prone ways and clouded intellect have left the brain stark dry and unrepentant in these times of record criminal activity. Take action Governor Kemp!

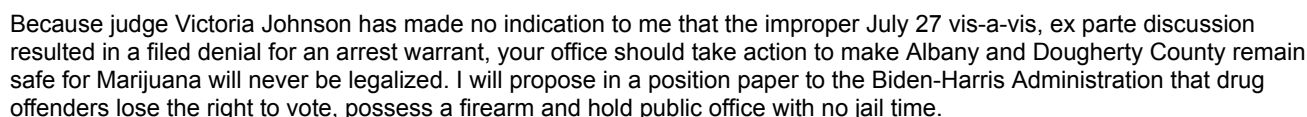

I will be manually signing this email and sending a photocopy to your offices.

I am writing this email to request a meeting with your office to undertake procedures to present my criminal complaint re: Jermaine Spence v. Vincent Gilbert, et al. (5 other Defendants) to a Grand Jury for a "True Bill" finding and Indictment to the Superior Court. In July 2021 I named all 6 Defendants their Individual Capacities in a domestic court rather than international court--the Magistrate Court of Dougherty County.

Alternatively If you are empowered to enter an Information against the named Defendants please do so. I do hope that you will promptly communicate your intentions to me.

Thirdly it is my hope to re-present the matter at hearing before the Honorable Judge Baxter Howell who instructed me in his emailed reply to present to the Grand Jury (SEE email below). In January 1981 I was born in South Georgia's Albany, attended a Baptist church since February 1986 and I am familiar with the process of a probable cause hearing before a Magistrate judge who is empowered to singularly bound a felony case to Superior court, having filed a complaint in Chatham County while incarcerated in an interlocutory setting at DBHDD-Savannah. Because Victoria Johnson did not give me confirmation that my case was docketed I imagine that no official Filed ruling on the matter exists.

In November 2020 I learned that 4 female nurses at Aspire were using false aliases that they acquired from the Secretary of State website. (One of the four misspells her State of Georgia state-issued badge name). Kindly, knowthat forms of biases perpetrated by Defendant Soles, a Allied Health supervising principal at Soles, will not be accepted as his conduct at Aspire,

southwest Georgia's mental health clinic, is unfathomable.
