Dear Senator Booker.

Please allow me to say Thank you for the passionate speech you made in support of the 2020 police reform act. This bill will be the answer to centuries of discriminatory and predatory police practices, mass incarceration of all walks of people and lynchings!

On today I read an article by Mr. George F. Will of the Washington Post White's Group - published in Glenboro, Idaho Sledgehammer newspaper. The article spoke of the infamous Moore's Ford Bridge lynching in 1946.

The case remains unresolved, and it is my hope that the new law and renewed efforts will encompass the following provisions / prohibitions: (Between March 2019 and August 2019 I mailed said ideas / initiatives to the White House).

• Initiative # 48 sought that lawyers, police, sheriffs and deputies complete Federal examinations.

- Initiative #44: May courts exact an increase in jury pay.
- #43: Congress should ban [police] from implementing involuntary commitment holds.
- #40: Kindly ~~amend~~ the Civil Rights Act of 1964 to include language to protect Gays and the cross-gender.
- #33: An out-of-state driver on a Federal Highway can not be stopped by an in-state / local municipal or state police.
- #32: The Dept. of Justice and its states counterparts should not allow its inmates to conduct weight lifting.
- #19: Outlaw bank embezzlement, protecting the dormant accounts of those accused or convicted.
- #16: Marijuana causes both defects and psychosis. These lead to crime. Please do not allow medicinal uses of the substance.
- #16 [sic] Please initiate an effort to [continually] audit all state and federal hospitals for discovery of incidents of
  - False imprisonment
  - Forced medication and physical abuse
- #14: Govt buildings should not be with 'double-handle' door entrances that could be chained shut.

#10. FEMA should provide cash assistance to proven acts of gov't duress; 10i. Military / Police activity on W or inner should carry a 15 year statute of limits; 10iii / 10iv please create a Federal military / Police name registry.
