ORDER # 3.3 of the *Holy Triumvirate*:

Historical Background

Abstract / Overview

Whereas this Order # of the *Holy Triumvirate* seeks that 1) a CEASE fire in Ukraine be issued and troops commence

HUMANITARIAN EFFORTS; 2) a national vote in Ukraine for or against REUNIFICATION occur; 3) a PAYMENT of a ₱120,000 PREMIUM to all Ukrainian farmers, manufacturers and natural resources producers for an unlimited amount of goods; 4) Mr. Jinping (习近平) please DE-FUND and DISBAND the European Union.

SUBJECTS &

TARGETS:

- **Ukraine, Europe**
- **Volodymyr Zelensky**
- **The European Union**

Comfort:

Since February 2022 casualties in the Russo-Ukrainian conflict have continued to climb . Mr. Putin I seek that you order troops to engage in the transport of Ukrainian goods to Russia and undertake a less offensive posture in the region. Mr. Zelensky must SURRENDER his forces and end the Ukrainian DRAFT. Therefore no further forced military service shall be made against the male citizenry of Ukraine. Further all Ukrainian military bases are to serve the post-war RECONSTRUCTION activities.

Choice: A national VOTE shall occur within Ukraine that shall indicate FOR or AGAINST REUNIFICATION with Russia. Moreover Ms. Putin see that each Ukrainian Farmer, Manufacturer and Producer of Natural Resources receive a per annum PREMIUM of ₧120,000 in exchange for an unlimited amount of goods, which are to be transported to their intended recipient via Russian troops.

Charity: Rebuild Ukraine dear Russian troops and encourage Ukrainian brothers and sisters to serve the will of the Duma and Office of the President of the Russian Federation and Soviet Union.

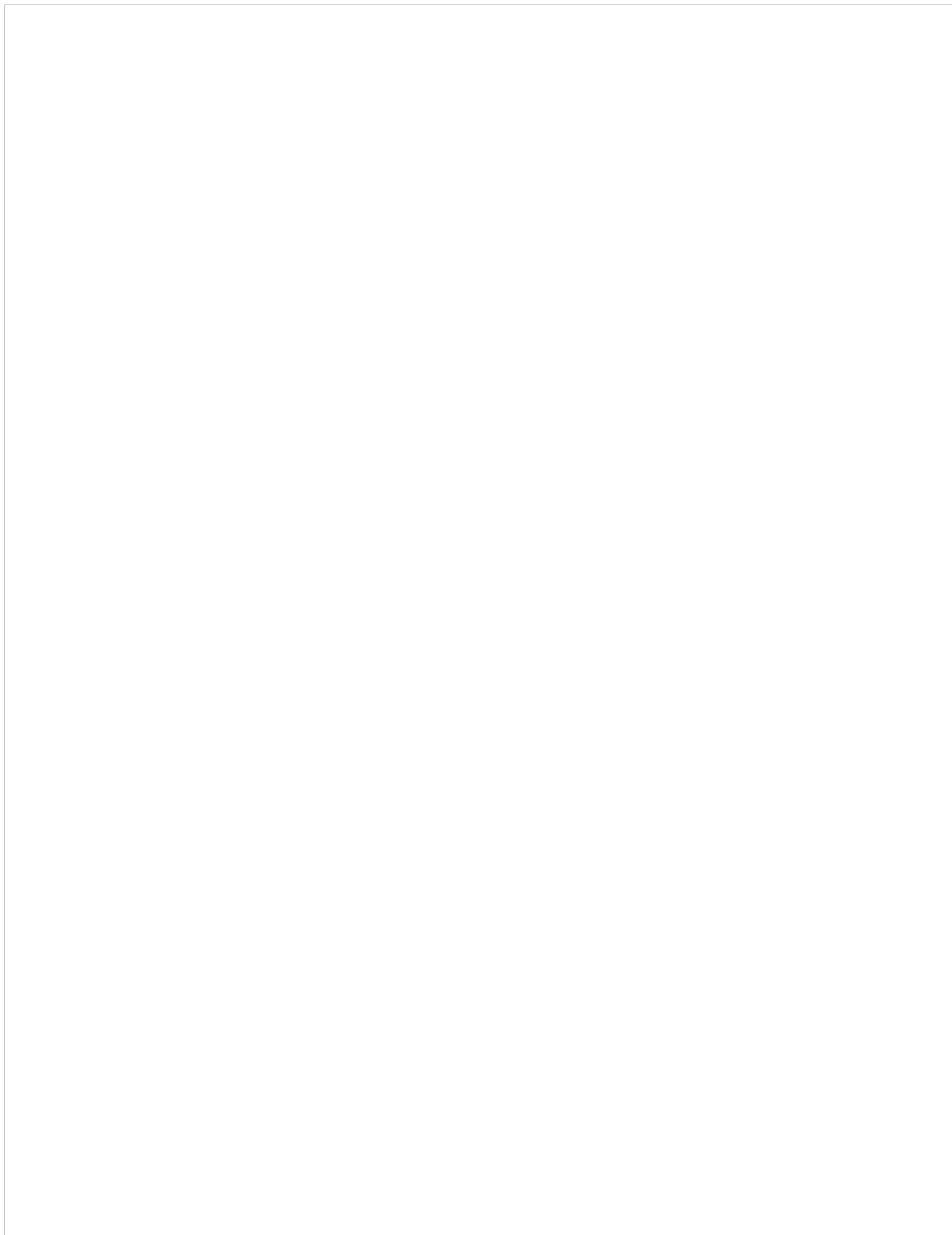

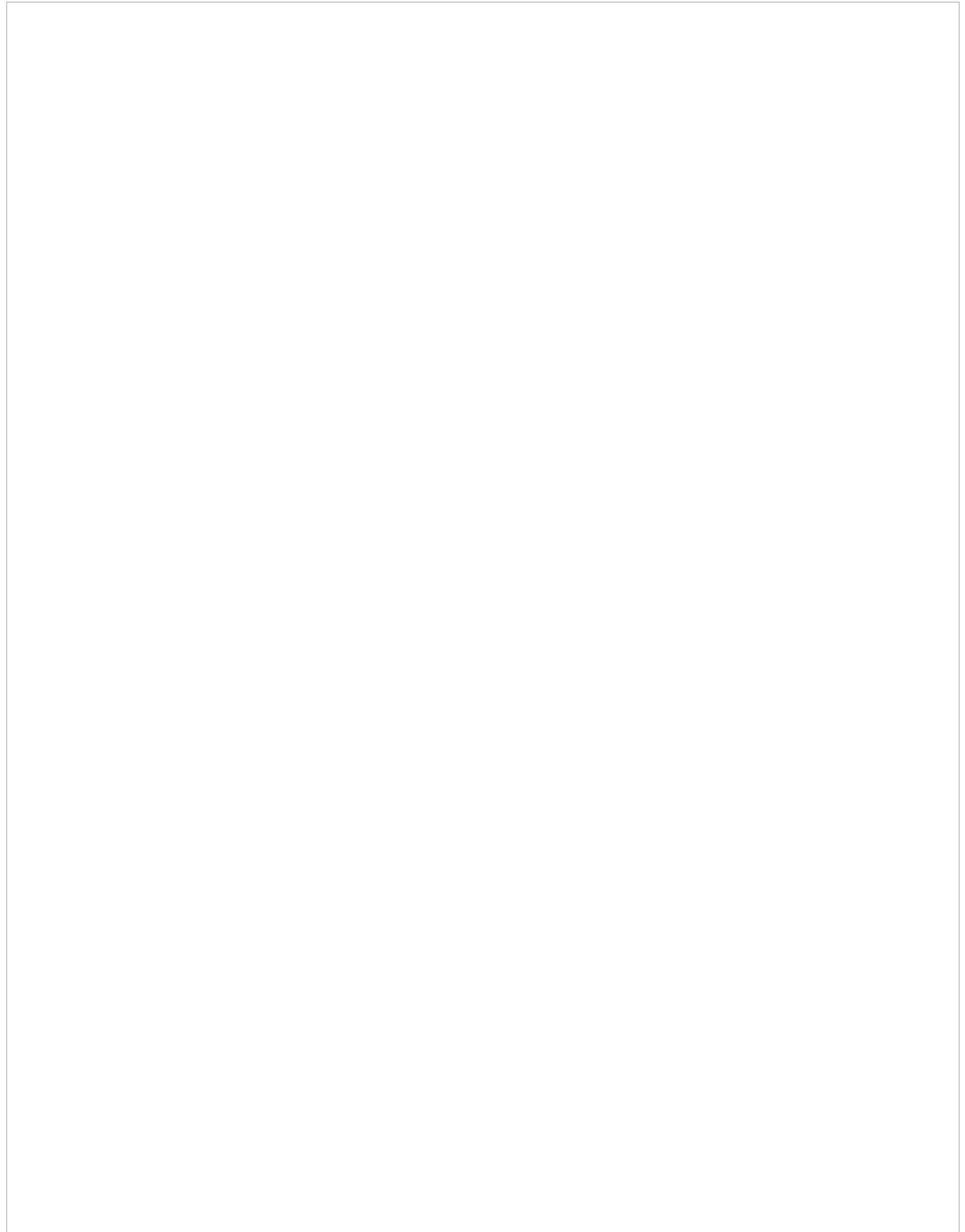
